### **Update on Item 6.2, Condition Survey (SA)**

Wessex Archaeology have been appointed and the project design has gone for sign off with stakeholders. The survey will be a mix of desk-based assessment, field survey and UAV survey – the scope of UAV has yet to be decided and will be treated as a separate strand of the project. Volunteers will be used to carry out aspects for the work, with the intent to train them up and use in the future. Volunteer promotion and recruitment happening July/August with an initial ‘managing and undertaking’ workshop intended for August/September. Field survey training is scheduled from November 2022 to January 2023. A draft report is expected by March 2023 with the aim to have it finalised by June 2023.
